

## **TERMS & CONDITIONS**

All services purchased from Barre Life Fitness Studio must be preceded by the applicant acknowledging, by way of completing a Liability/Waiver Form, that he/she has no physical limitations preventing him/her from participation. The applicant agrees to abide by the rules and regulations of the Barre Life Fitness Studio and acknowledges that these rules may change from time to time. Furthermore, all applicants release Barre Life Fitness Studio, its owners, directors, managers and all employees of all liability regarding 1) Any injury to self or child. 2) Any loss or damage to personal property. If purchasing packages that require payments to be made in instalments, the applicant agrees to approve such instalments be made by credit card on the dates as predetermined in the services contract.

### **Refund Policy Classes/Packages:**

All payments must be received prior to the start of class or private sessions. Classes/Class packages are non refundable and non transferable.

### **Registered Events & Workshops**

It is our policy that no refunds will be provided for Workshop or Event Cancellations. However, a credit to your account will be made available up to (5) days prior to the event or you may arrange for an alternate person in your place. We will only offer a refund for an event or workshop if Barre Life needs to cancel the event or workshop due to low sign ups.

### **Retail Goods**

Any retail goods purchased at Barre Life Fitness Studio can be exchanged or returned within 7 days of purchase with receipt. Please note that all items must be in original condition with all packing material and documentation.

### **Expiry Dates Policy:**

- All single class, class pass passes are valid for a period of 3 months from the first day of visit.
- All unlimited packages are valid for a period of the specified package bought from the date of the first visit.

## **Suspension and Cancellation Policy**

### **Auto Renew Suspension Terms:**

- You can freeze your monthly pass twice a year at any time within a 6 month period.
- The freeze can only be requested in 1-month increments
- Following the end of your requested freeze period, your monthly auto-renew will automatically be reactivated

### **Auto Renew Cancellation Terms:**

- To request a cancellation, please contact us via email 30 days prior to the cancellation.
- This request must be received at least 30 days in advance of your billing cycle. (ex: If you are scheduled to be charged on February 14th and you want to cancel for the month of February, you must tell us by January 14th)
- Cancellations must be made 30 days in advance of next payment. 1 month hold every 6 months

### **Class Reservations and Cancellation Policy:**

Class Reservations: Class reservations are open 7 days prior to the scheduled class and close 60 minutes before the class starts. We strongly recommend reserving your spot for classes ahead of time to accommodate capacity requirements. Please do not reserve a spot in any back to back class on the chance that you may not be able to do the second one. It would be easier for us to reserve the spot for you in the event you choose to stay than cancel a held spot. Each class holds a maximum of 8-12 clients. ALL reservations will be held up to 5 minutes prior to the class start time. 5 minutes prior to the start of each class, all open spaces will be given to clients on the wait list for that class. All classes from Barre Life must be preceded by the applicant acknowledging, by way of completing a Liability Release Form, that he/she has no physical limitations preventing him/her from participation. Minimum age for participation is 16 years of age. All applicants under 18 years of age must have written consent from a parent or guardian.

**Client Class Cancellation Policy:**

Class cancellations must be made no later than 2 hours prior to start of the scheduled class start time. Any class reservation that a client cannot attend for any reason must be cancelled by phone 905 337 8338, email or online cancellation.

**Client Non-Attending Policy:**

Missed classes without the appropriate notice outlined in the class cancellation policy will be subject to the following:

- All class pass holders will be subtracted a class on their pass
- For monthly Auto-Renew clients, a \$12 'no-show or late cancel' fee will be automatically charged to your credit card on file. A \$12 'no-show or late cancel' fee charged to accounts without a credit card on file must be paid by your next visit.
- If failure to cancel for classes you have signed up for occurs for 3 instances or more, pre-sign in privileges will be suspended for 1 week. If after re-instatement, failure to cancel occurs again, pre-sign up privileges will be suspended indefinitely.

**Minimum Class Cancellation Policy:**

Barre Life Studio requires a minimum of 4-6 reserved participants in order to run a class. All classes that do not meet this requirement will be cancelled. Anyone scheduled in a low attendance class will be notified of the cancellation and given the opportunity to reserve a spot in another class. Any morning class that does not meet the class minimums will be cancelled at 10:00pm the prior evening. Any evening classes that do not meet the class minimums will be cancelled at approximately 2:00pm the same day of the scheduled class. It is imperative that all clients check the schedule prior to attending a class to ensure no changes have occurred. Reserving your class ahead of time (online or by phone) is very important. By doing so, the number of class cancellations resulting from low reserved attendance will be greatly diminished.
